

## ORDINANCE NO. 257

AN ORDINANCE OF THE BOROUGH OF PATTERSON HEIGHTS, BEAVER COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 251 RELATING TO THE OBLIGATION OF OPERATORS OF VEHICLES TO COMPLY WITH STOP SIGN REGULATIONS, PROVIDING PENALTIES FOR THE VIOLATION THEREOF AND IDENTIFYING INTERSECTIONS AT WHICH STOP SIGNS ARE TO BE ERECTED

NOW, THEREFORE, be it ordained and it is hereby enacted by the Council of the Borough of Patterson Heights, County of Beaver and Commonwealth of Pennsylvania, by the authority of the same as follows:

SECTION 1: Except when directed to proceed by a police officer or appropriately attired persons authorized to direct, control or regulate traffic, every driver of a vehicle approaching a stop sign shall stop at a clearly marked stop line or at the point nearest the intersecting roadway where the driver has a clear view of approaching traffic on the intersecting roadway before entering. If, after stopping at a clearly marked stop line, a driver does not have a clear view of approaching traffic, the driver shall, after yielding the right-of-way to any pedestrian in the crosswalk, slowly pull forward from the stopped position to a point where the driver has a clear view of approaching traffic. The driver shall yield the right-of-way to any vehicle in the intersection or approaching on another roadway so closely as to constitute a hazard during the time when the driver is moving across or within the intersection or junction of roadways and enter the intersection when it is safe to do so.

SECTION 2: Stop signs, uniform in appearance with “STOP” signs used by the Pennsylvania Department of Motor Vehicles, are to remain erected and maintained at the following streets and/or avenues within the Borough:

**STREETS**

- Travelling on Fourth Street at the intersection with Darlington Road;
- Travelling on Fourth Street at the intersection with Eighth Avenue (4-way Stop);
- Travelling on Fourth Street at the intersection with Sixth Avenue (3-way Stop);
- Travelling on Fourth Street at the intersection with Fifth Avenue (3-way Stop);
- Travelling on Fifth Street at the intersection with Darlington Road;
- Travelling on Fifth Street at the intersection with Eighth Avenue (4-way Stop);
- Travelling on Fifth Street at the intersection with Seventh Avenue (4-way Stop);
- Travelling on Fifth Street at the intersection with Sixth Avenue (4-way Stop);
- Travelling on Fifth Street at the intersection with Fifth Avenue (4-way Stop);
- Travelling on Fifth Street at the intersection with Fourth Avenue (3-way Stop);

SECTION 3: Any person who shall violate any of the provisions of this section shall, upon conviction thereof, be sentenced to pay a fine of twenty-five (\$25.00) dollars and costs of prosecution, and, in default of payment of such fine and costs, to imprisonment in the county jail for not more than ten (10) days.
