The minutes of the previous meeting were approved upon a motion by Mr.Barsottini, seconded by Mrs.Barsottini.

The Sec. advised that the Beaver Co.Boro Assoc.meeting will be May 6,2010.

Mr.Jason Petrella introduced himself as a candidate for State Rep.in the 15th district.

Streets: Mr.Harker was given permission to have the streets swept.Mr.Harker reported that the broken axle on the truck has been repaired & that the plow would be good for one more year.Mr.Harker stated that he had heard a report that the City of Beaver Falls would be taking over the street dept.Mr.Sadaka replied that he will discuss this with Beaver Falls ,& if the numbers add up,Mr.Harker would continue to work & be hired by Beaver Falls.

Mr.Harker advised that Reed Oil would provide a tank for diesel fuel & top of the tank with fuel. The matter was tabled & the Sec. will check with Ins. Co.

Mr.Mannix presented a lease with the Fire Dept.It was moved by Mr.Kinger,seconded by Mrs.Barsottini & passed that the lease be approved with changes in item 4 to read 20 hours of training a year & costs of the elevator not be shared by the Fire.Dept.

Mr.Bellan reported on the EOC meeting at the Patt.Twp.Mun.Building,which was held to work on an emergency evacuation plan.There will be a drill training date on 4/20/10 at the Patt.Twp.Municipal Building.

Fire Chief Portman gave the Fire report for March.

Mr.Mannix presented the revised rental Ord.Amendment to increase the fees.It was moved by Mr.Barsottini,seconded by Mrs.Barsottini & passed to amend Ord.No.245 increasing the fees to \$50.00 for each reinspection & \$100.00 for the annual license & inspection fee.
